AND

Chairman: (1) SUKUMAR SARDAR, son of Sri Becharam Sardar, by faith - Hindu, by Caste- Scheduled Tribes by occupation - Social worker, Age: 42 Years, residing at Village- Mollahati Kalibari, P.O. & P.S. : Gopalnagar, Dist.- North 24 Pargonus, PIN -743261, W.B., will be called **Chairman and Trustee for life time**, and **Trustees:** **(2) KANAI SARDAR**, Son of Late Gagendeeep Sardar, by faith - Hindu, by Caste- Scheduled Tribes, by occupation- Social worker, age- 54 years, residing at Promodnagar Colony, P.O. & P.S. Bongaon, District- North 24 Pargonus, PIN: 743235, W.B., **(3) BIPLAB MUNDA**, son of Late Bablu Munda, by faith - Hindu, by caste - Scheduled Tribes, age- 21 years, by Occupation- Student, residing at Village & P.O.: Akaipur, District- North 24 Pargonus, PIN - 743710, & **(4) SHAMAL SARDAR**, son of Krishna Sardar, by faith - Hindu, by caste - Scheduled Tribes, age- 30 years, by Occupation- Social worker, residing at Village - Hatgacha P.O.- Abad Kuliadanga, P.S. - Hasnabad, District- North 24 Pargonus, PIN - 743456 hereinafter jointly called the **TRUSTEES** (which expression shall unless excluded by or repugnant to the subject and context be deemed to include the trustees for the time being of these presents and/or Survivor or Survivors of any of them and their successor or successors in office) of the **OTHER PART**.

WHEREAS:

1. The SETTLOR is desirous of creating an endowment by setting apart and establishing a Fund for the Public Religious and Charitable objects and purposes in corner of World hereinafter expressed. Settler shall open a Bank Account to the name of this Trust as "**INDIAN SCHEDULED TRIBES & SCHEDULED CASTES DEVELOPMENT SOCIETY**" and it will be operated jointly with the Chairman of this Trust, to work freely in the corner of World.
2. The TRSTEES have at the request of Chairman agreed to act as TRUSTEES of these presents upon the terms and provisions hereinafter contained.

NOW THIS INDENTURTE WITNESSETH as follows:

- I. In order to effectuate the said object of creating and establishing a Public Charitable Trust, the SETTLOR has delivered to and made over to the TRUSTEES a sum of Rs.10,000/- (Rupees Ten thousand) only with intent to part with all his right, title and interest claim therein and vest the same in the TRUSTEES to have and to hold the same and the investment or investments for the time being representing the same and all other properties that may for

the time being represent the trust estate together with all additions and accretions thereto and all accumulated income thereof and all other property or properties that may be acquired out of the same or otherwise may hereafter be subject to the trust (hereinafter referred to as the TRUST FUND) for the charitable object and purpose and uses hereinafter expressed with the powers and on the terms and conditions herein contained of and concerning the same.

2. The name of the Trust shall be:
"INDIAN SCHEDULED TRIBES & SCHEDULED CASTES DEVELOPMENT SOCIETY" and the office of the shall be situated at Village- Mollahati Kalibari, P.O. & P.S. : Gopalnagar, Dist.- North 24 Pargonus, PIN -743261, W.B., which may be shifted from time to time to such other place or places as the Chairman may deem fit.
3. The object of the Trust shall be Charitable for human life:
 - (i) To established promote, Rights of Scheduled Castes & - Scheduled Tribes of the World, Livelihoods & others, set up & Human Rights along with women, Child, Disabled, Neediest right, run Humans body bank as Kidney, Heart, Bone, Eye, Skin etc. organ from Dead-bodies, Blood Bank, maintain, assist, finance, support and/ or aid to protect rights of livelihoods or help for needy in the setting up and/ or running schools, running religious institutions as Madrasah, Muths, Churches, Missions, Handicapped institutions and other residential institutions as orphanages, helpless or needy or livelihoods. Widow and Aged homes, lunatic asylums, house for poor and pauper or other establishments for relief and/ or help to the poor, pauper, children, old age persons etc. and inform people and/ or destitute.
 - (ii) To give, provide and/ or render help and assistance in cash or kind to poor and/ or destitute Scheduled- Castes & Scheduled Tribes, widows, pauper, handicapped, children, women, neediest part of society etc.
 - (iii) To give, provide and/ or render help and assistance to and/or implement any scheme for providing livelihood and uplift men of the poor and needy etc.

- (iv) To give provide and/ or render food, medicine, cloths, residents, conveyance allowance etc. and other help and/ or assistance in any shape or form to the poor deserving any needy person.
- (v) To give, provide and/ or render monetary and/ or other help and assistance for the relief of persons and animals affected by natural and other calamities such as food, fire, famine, cyclone, earth- quake, storm, accident, pestilence, drought, epidemic, etc. Unbearable cost of living and the like, to give donations, subscriptions or contributions to institutions, establishments, centers or persons doing relief work on such occasions.
- (vi) To start, maintain and assist any relief measures in those parts which area or become subject to natural calamities such as food, fire, drought, famine, cyclone, earth-quake, epidemic, storm, accident, pestilence, etc. as per need of social.
- (vii) -To establish, maintain or grant aid for the establishment or maintains of wells tube-wells, tanks, water reservoirs and trees and constructions of and repairs to paths, roads, bridge etc. Open industries, small industries, workshops, Tea Gardens, fruit and vegetable Gardens, agricultural fields, horticultures, fisheries, echo-parks, ashrams for needy and helpless, mills, computer educational and training institutions, AYUSH and other hospitals, medicine counters, Yoga centers', animal gardens or zoologies, saw mills, wheat and rice mills, ply wood mills etc. factories/industries for the use of the public and livelihoods /needy life.
- (viii) To give, provide, distribute dhotis, blankets, rage woolen clothing, quilts of cotton, woolen, silk or other varieties of cloth or other articles of necessity and facilities for the poor or needy of societies.
- (ix) To open, found, establish, promote, set up, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running schools, colleges, human rights training centers, lectures halls and other establishments or instructions for advancement of education and of knowledge on arts, science, literature, humanities and all other useful

subjects in all their manifestations of socials on Government / private land.

- (x) To open, found, establish, promote, set- up, run, maintain, assist, finance, support, and/or aid or help in the setting up and/or maintaining and/or running hospitals, boarding, houses, libraries, reading rooms, gymnasium, yoga and other training and vocational institutes etc on Govt./private land.
- (xi) To promote/ run, advance and encourage and/or aid in helping, promoting. Advancing and encouraging open primary, secondary, higher secondary educational institutions, colleges as Post Graduate, PTTE/ B.Ed/B.P.Ed / TET /SLET / JEE/ etc institutions for religious/ non-religious and education including technical and medical education also physical training, training of handicrafts, fine art and other useful arts, crafts among the public including the establishment and maintenance of Shilpa- Shikshalayas, Kala Kendras and other welfare centers for societies.
- (xii) To foster and encourage education and training in handicrafts, fine arts, among women folk in general and establish and found institutions imparting such education and to establish, maintain, support or help by monetary gifts or otherwise, centers and institutions for women children and needy, women of all communities, illiterates, and to provide social welfare works for women, children, handicapped and needy etc.
- (xiii) To meet traveling, boarding and lodging expenses going abroad for higher commercial and technical educations. We shall abide by all the constitutions of all countries, law and order of all countries, rules and regulation of all countries, Courts of all countries, all the rights of men, women, children, handicapped, needy of societies etc. along with livelihoods of all states and countries in corner of World.
- (xiv) To grant, pay or give scholarships, stipends, prizes, rewards, allowances and other financial assistances or help to Scheduled Castes & Scheduled Tribes, needy in cash or kind to students with a view to help them in pursuing their studies in schools, colleges, educational institutions, technical institutions, art schools, institutions teaching commerce and other arts

including teaching of cultural arts or other training, research or educational works in corner of world.

- (xv) To open, found, establish, promote, set- up, run, maintain, assist, finance, support and/or maintaining and/or running hospitals, charitable dispensaries, maternity homes, child welfare centers, human rights institutions, convalescent houses, sanatoriums, hostels and other similar institutions or centers for rendering or providing medical relief and/or aid to the suffering humanities or for research centers and institutions for promotion of research and education for medical science including surgeries etc.
- (xvi) To open, found, establish, promote, setup, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running by monetary gifts or otherwise, centers, stadium, playgrounds, and parks, echo-parks for public uses, sports, and games and other social welfare and/or activities etc. in corner of World.
- (xvii) To open, found, establish, promote, set up, run, maintain, assist, finance, support and/or aid or help in the setting up and/or maintaining and/or running institutions, centers, auditoriums and the like for the running of welfare and other services to the public and to provide meeting room etc. for socially useful activities and functions.
- (xviii) To open, found, establish, promote, set up, run, maintain, assist, finance, support and/or aid or help in the setting up establishment, maintenance and/or running dharmasala, wells, deep, tube wells, tanks, roads and micro finances etc. for the profit of societies
- (xix) To promote, organize, administer, establish, support, maintain and/or grant aid to any person, institutions or societies or organizations etc. whatsoever having for its objects of charitable purposes and to incur expenditure in connection therewith.
- (xx) To renovate or repair any such temples, mosques, gurudwaras, churches or other religious and non-religious places which is notified by the Central Government in the Official Gazette to be of historic, archaeological or artistic importance or to be a place of

public worship of renown throughout any State/ States or countries or corner of world.

- (xxi) To promote, assist and/or maintain all activities by whosoever carried on or wherever carried on in Indian conformity with the objects of the Trust and as are conducive to the well being and general welfare of the nation of world or are conducive for advancement of any object or objects of general public utility not involving/ carrying on any activities for profits.
- (xxii) To help in the preservation of cattle, useful animals and livelihoods of the World.
- (xxiii) To publish and or publishing books, pamphlets periodicals and newspapers in India or outside of India for the World for the spread and advancement of educations, cultural, awareness of human rights, act, law, rules of all states, countries and of the World etc.

If any one or more of the objects specified in clause (3) of these presents are held not to be objects of public charitable nature, the Trustees shall not carry out such object or objects as if the same are not incorporated in these presents but the validity of the trust created by these presents as a trust for public charitable purposes shall not be affected in any manner.

- 4. The financial year of the trust shall end on 31st March, of every year provided that the Board of Trustees or Chairman shall be at liberty to change the same from time to time if they so deem it fit and proper. The first financial year of the trust shall close on 31st March, 2015.
- 5. The Trustees shall from time to time after meeting the expenses incidental to the management of the Trust Properties and of the Trustee decided the particular object or objects for which the income or corpus of the Trust Fund or properties for the time being available shall be applied, in present of the Chairman.
- 6. The Trustees may accept any denotation contribution by order of Chairman in cash or in kind from any person, firm, company, corporation, associations, institution or trust (including the settler or the trustees or any of them) for the furtherance of the objects of the trust or for any one or more of them upon such terms and conditions as they may in their absolute discretion think, fit and which are not

inconsistent with the objects of the trust. The trustees may also take over the management of any other charitable or public institutions on such terms as they / Settler think fit and may manage such institutions.

7. Without affecting the generality of powers and functions of the Chairman to manage and administer the trust, the Board of Trustees/Settler or Chairman shall have the following functions.
 - (i) To borrow if needed against the security of the assets of the trust by way of bank overdrafts, loan or otherwise, as may be necessary, for the benefit of the trust and for more effectively carrying out the objects of the trust provided however the trustees / Chairman mutinously agree on such borrowing and limited to the terms of their decision or agreement and to authorize two or more of the trustees to execute such documents, deeds papers, etc as may be necessary in connection therewith.
 - (ii) To arrange for and or authorize the signing or execution of any agreement, contract, document of any other paper or writing required to be signed or executed on behalf of the trustees by any tow of the trustees to be nominated in this behalf by the Board of Trustees/ Chairman and to make the same effective and binding as if the said agreement, contract, instrument or document or paper or writing were signed by all the trustees/ Chairman.
 - (iii) To appoint of make provision for the appointment of a subcommittee of trustees and or others to attend to or supervise or conduct specified jobs or functions or trust matters in such manner and subject to such rules regulations as the trustees/ Chairman may prescribe.
 - (iv) To authorize any one or more trustees to hold any property or any fund or any investment of the trust subject to such terms and conditions, rules and regulations as the Board of Trustees or the Chairman may take steps from or in time to time, as he/she think fit and proper.

- (v) To spend any portion of the corpus or the income of the trust fund for purchasing any land and or constructing any building or buildings for and in the name of the trust for the purpose of carrying out promoting and or executing any or all of the object of the trust.

- 8. The TRUSTEES or Chairman shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of trust properties or in relation to the carrying out of the objects and purpose of the trust as well as of all assets, credits and effects of the trust properties.

The Trustees shall each year issue a report setting out the accounts showing the income and expenditure of the Trust for the preceding year not later than six months from the end of the preceding year of account.

The accounts of the Trust shall be audited every year by a Chartered Accountant who may be appointed for the purpose by the Board of Trustees or the Chairman and the audited statement of accounts together with Auditors' Report shall be laid before the Board of Trustees or Chairman for approval.

- 9. The TRUSTEES may invest the Trust Estate either in the purchase of immovable properties or of mortgage immovable properties, or in such manner as allowed by law as may be in force from time to time and to convert, alter, vary, dispose of or transfer such investments from time to time provided that such investments shall not be made which are directly or indirectly for the benefit of any person referred to in subsection (3) of section 13 of the Income Tax Act, 1961, or any subsequent amendments as may be made from time to time.

- 10. If the income from the trust property in a particular year is not fully utilized, the unexpended income subject to the applicable provisions of the Income Tax Act 1961, shall be carried over to the next or years and spent in such subsequent year or years for the advancement of any of the object of the trust.

The Board of Trustees or Chairman shall be empowered to invest the funds of the Trust in movable or immovable properties, in such manner as they deem fit for the purpose

of the objects of the trust provided that such investment shall be in accordance with the provisions of Section 13(1) read with Section 11(5) of the Income Tax Act, 1961 as well as of any other law for the time being in force as are applicable to charitable trusts.

11. The Chairman shall be at liberty to Sale / Donate / Gift such portion or portions of the movable or immovable properties forming part of the Trust Estate either by public auction or by private contract at such price or prices and on such terms and conditions relating to title or otherwise in all respects as they may in their absolute discretion think fit and to rescind or vary any contract for the sale thereof and to resell the same without being answerable for any loss occasioned thereby and to execute all conveyances or other assurances and to pass valid and effectual receipts and discharges for all moneys received by them.
12. The Settler and Chairman or the Chairman shall keep an account or accounts with any bank or banks, to jointly or single by the Chairman or with operator/s, the such Bank/s account or accounts whether in debit or in credit and to give all appropriate instructions to the banker or bankers concerning the operation of the such Bank/s account or accounts or to authorize by appropriate resolution one or more of the trustees jointly or along as the Chairman or with an agent appointed by the Board of this Trust or by **the Chairman** in this behalf to operate such Bank/s account or accounts.
13. The Chairman may pay all charges and outgoings payable in respect of any immovable property for the time being forming part of the TRUST FUND and may carry out repairs required to be done to the same and keep the same insured against loss or damage by fire and may incur all other costs, charges, and expenses incidental to the administration and management of the Trust Estate and the properties for the time being belonging to the trust as they may in their absolute discretion or the Chairman as he/ she deem fit.
14. The Chairman may manage or supervise the management of any lands here determents, and premises for the time being comprised in the Trust Estate or any part thereof with power to erect, pull down, re-build add to, alter and repair houses and other buildings and to build drains and make roads and fences and otherwise to improve and develop and

to cultivate or cause to be cultivated all or any of the said lands, here determents and premises and to insure house and building against loss or damage by fire and/or other risks or to let, lease, gift etc. make allowances to and arrangements with tenants/ owner, agriculturists and generally to deal with the said lands, here determents and premises as the Chairman may deem fit.

15. The Chairman may appoint secretaries, Managers, Lawyers, Solicitors, Auditors, Architects, Engineers, Surveyors, Gomastas etc. or other employees for the purpose of management and supervision of the Trust Estate, for collection of rents, effects and profits, for keeping the account and records and for other purpose of the trust. **The Chairman will be life time post holder.**
16. The TRUSTEES or in absentee of them, the Chairman may establish their office at such place or places and may change such places from time to time or as Chairman may think fit.
17. The TRUSTEES or Chairman may demise the immovable property or properties for the time being and from tome to the trust either from year to year or for any fixed or for any term or years or on monthly tenancies at such rent and subject to covenants and conditions as they may thing proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they thing proper.
18. The Chairman shall have full power to compromise or compound all actions, suits, and other proceedings and settle differences or disputes to arbitration and to adjust and settle all account relating to the Trust Estate and/or the Trust Properties and to do all other acts and things fully and effectually without being liable or answerable for any bona fide loss occasioned thereby, in absentee of Trustees, the Chairman shall take steps as he/she think fit.
19. The TRUSTEES and Settler, or in absentee of them, the Chairman may join, co-operate and amalgamate the trust created by these presents or any portion thereof with any trust or institution having allied and or similar object upon such terms as he/ she may in absolute discretion as he/ she (Chairman) think fit.

20. The TRUSTEES and Chairman may from time to time frame schemes and rules regulations to carry out the objects of the trust and for managing the affairs of the trust to vary the same from time to time as the trustees or the Chairman may in their discretion deem fit and proper.
21. The receipts granted by the TRUSTEES / by the Chairman or any one or more of them for any moneys, stocks, funds, shares, securities paid, delivered or transferred to them in exercise of the trust or powers hereof shall effectually release and discharge the persons paying delivering or transferring the same there from or being bound to see the application thereof or being answerable for the loss or misapplication thereof. In absentee of them, the Chairman shall take steps.
22. The TRUSTEES, Chairman, Settler or in absentee of them, the Chairman shall be entitled at their discretion from time to time to start, discontinue, abolish and restart any charity or charitable institutions, to impose any condition or conditions to any subscription or donation made by them and to earmark any portion of the Trust Property or income for any particular object or objects.
23. The TRUSTEES or the Chairman may reimburse themselves and pay and discharge out of the TRUST FUND all incurred by them in or about the execution of the trust or any of their duties under these presents including traveling expenses. But will not be entitled to any remuneration.
24. All the TRUSTEES unless voluntarily resign or otherwise decide, shall continue to be the trustees during the term of their natural lives or Trustees, Settler, Chairman or in absentee of them, the Chairman shall take disciplinary steps such as removal, dismissal etc. of any Trustee or Settler, as he/ she may think fit.
25. The number of trustees shall be not less than two and not more than nine or Chairman may deem fit to phasing it.
26. Any trustee may retire at may time without assigning any reason and without being responsible for any costs occasioned by such retirement.
27. The surviving or continuing TRUSTEES may notwithstanding any vacancy in their board act as trustees PROVIDED HOWEVER that in the number of TRUSTEES

shall fall below the minimum fixed by these presents, the trustees shall not, except for the purpose of filling any vacancy, act so long as the number is below the said minimum or Settler or Chairman, or in absence of them, the Chairman shall take steps as he/she think fit.

28. Two TRUSTEES at a meeting shall form a quorum, in present of the Chairman, for any meeting of the this Trust, TRUSTEES with consultation/permission of/ with Chairman, take appropriate decisions.
29. The SETTLOR and Trustee for the time being shall elect or select from amongst them as Trustees or by the Chairman.
30. All proceedings and questions and matters arising at the meeting of the TRUSTEES shall be decided by a majority of votes and in case of equality of votes the Chairman shall have a second or casting vote PROVIDED HOWEVER THAT notwithstanding anything herein stated no question dealing with the disposal of the corpus of any of the trust properties and/or investment out of the trust corpus shall be decided except with the consent of the Chairman of this trust.
31. In case of difference of opinion between the TRUSTEES the opinion of the majority shall prevail and if the TRUSTEES are equally divided in any matter, the Chairman shall have each casting vote or the Chairman shall take steps as he/she think fit for run this trust.
32. A resolution in writing circulated amongst all the TRUSTEES and signed by a majority of the trustees present in India/ world shall be as valid and effectual as if it has been passed at a meeting of the TRUSTEES duly convened and held.
33. Notice of the meeting of the TRUSTEES and all communications may be sent by the Chairman to the TRUSTEES or appropriate authorities at their addresses with registered post or Couriers or Electronic media or others way for the time being in the records of the trust. From as Address: Village- Mollahati Kalibari, P.O. & P.S. : Gopalnagar, Dist.- North 24 Pargonus, PIN -743261, West Bengal.
34. All meetings of the trust shall be held at such place and at such time as the Chairman of this trust shall decide from time to time.

35. A trustee who is unable to be present at a meeting of the TRUSTEES that send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned to the Chairman.
36. The minutes of the proceedings of every meeting of the TRUSTEES shall be entered in a book to be kept for that purposes and signed by the Chairman of such meeting or of the following meeting when they are read over and shall when so entered and signed be conclusive evidence of the business and other matters transacted at such meeting, in the absence of them, the Chairman shall take steps as he/ she think fit.
37. No person being -
 - (i) an undischarged insolvent; or
 - (ii) convicted of an offence involving moral turpitude; or
 - (iii) of unsound mind; or
 - (iv) a minor
 Shall not be eligible to be a trustee.
38. The power to appoint new or additional TRUSTEES, but so as not to exceed the maximum number and to fill vacancies in the office of the Chairman, shall vest in the continuing trustee or trustees.
39. A person shall cease to be a trustee in any of the following events:
 - (a) if he dies, or
 - (b) if he becomes bankrupt; or
 - (c) if he becomes insane or otherwise become incapable to act; or
 - (d) if he resigns his office.
 - (e) if not attend three meeting.
 - (f) if removed by the Chairman.
40. On a new or additional trustee being appointed and on his signifying his acceptance in writing to the effect of his accepting the appointment, the Trust property shall automatically vest in him along with the other TRUSTEES for the time being and he will be entitled to carry out all the duties and functions of a trustee without any other deed or writing.

41. The Board of Trustees shall be entitled to sue in the name of the trust and may similarly be sued in the name of the trust.
42. The Board of Trustees, may be a unanimous vote of all the TRUSTEES or order of Chairman for the time being except the trustee proposed to be removed, remove any trustee, permanent or otherwise, from office after finding the trustee proposed to be removed guilty of serious misconduct in relation to or concerning the trust estate or trust affairs and after arriving at a definite conclusion that for the reasons to be recorded in writing the continuance of the trustee proposed to be removed as trustee or these presents was desirable keeping to the objects of the trust in view and other related or connected matters provided however that no conclusion of such guilt shall be arrived at without giving to the trustee proposed to be removed a full and fair opportunity of explaining his conduct and/or the charges leveled against him for his removal. And the decision of the Board of TRUSTEES or the Chairman in this behalf shall be final and binding and shall not be called in question anywhere.
43. On dissolution of the Trust, the net assets of the Trust shall be transferred to an association of persons or trust or society having similar objects of this Trust.
44. The Trust is irrevocable.
45. Every Trustee shall be indemnified out of the fund in respect of any loss arising from or contingent upon any investment made out of the monies of the Trust unless such loss shall have been occasioned by one negligence and also every Trustees or the Chairman shall be indemnified out of the Trust against all proceedings, suits, claims, costs, damages and expenses occasioned by any claim in connection with the matters or affairs relating to the Trust created by these presents or in the exercise of powers or discretion vested in them by virtue of these presents.
46. For matters not provided for these presents, the provisions of the Indian Trust Act, 2 of 1882 and the Income Tax Act, 1961 and rules made there under will apply accordingly.

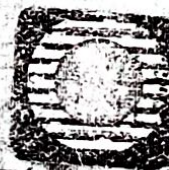

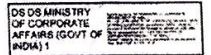
